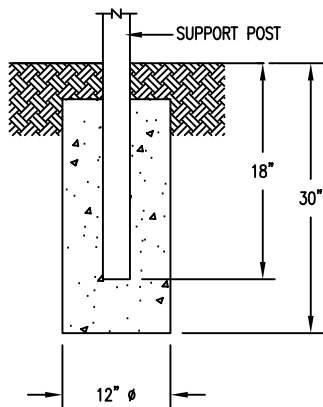
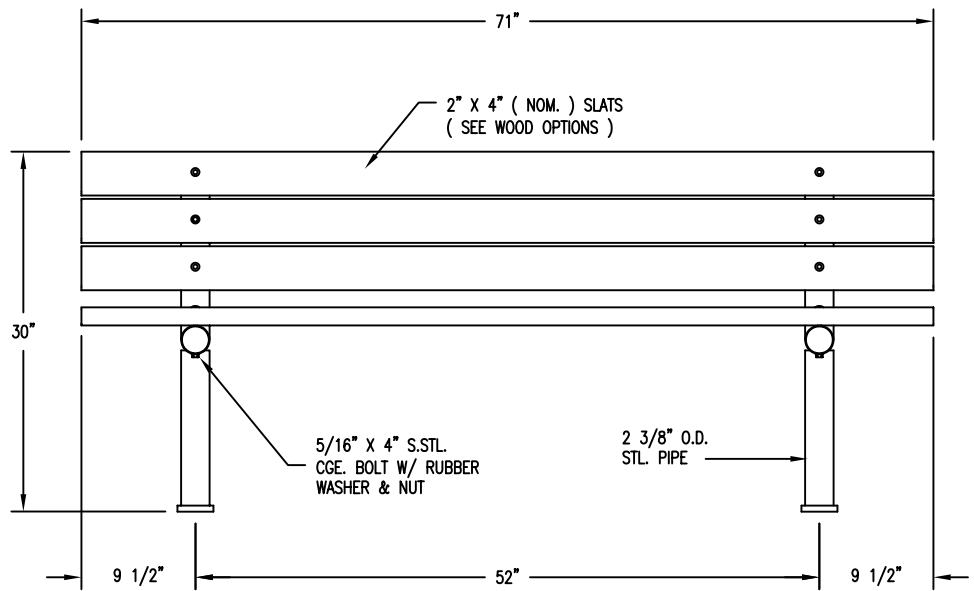
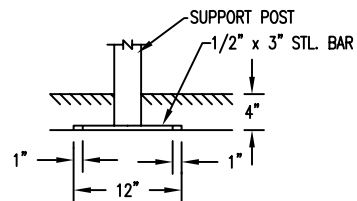
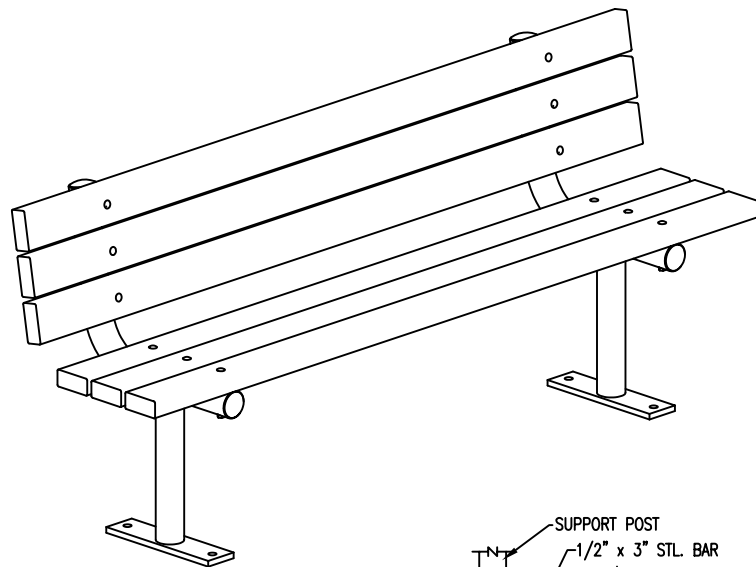


S-2 SURFACE

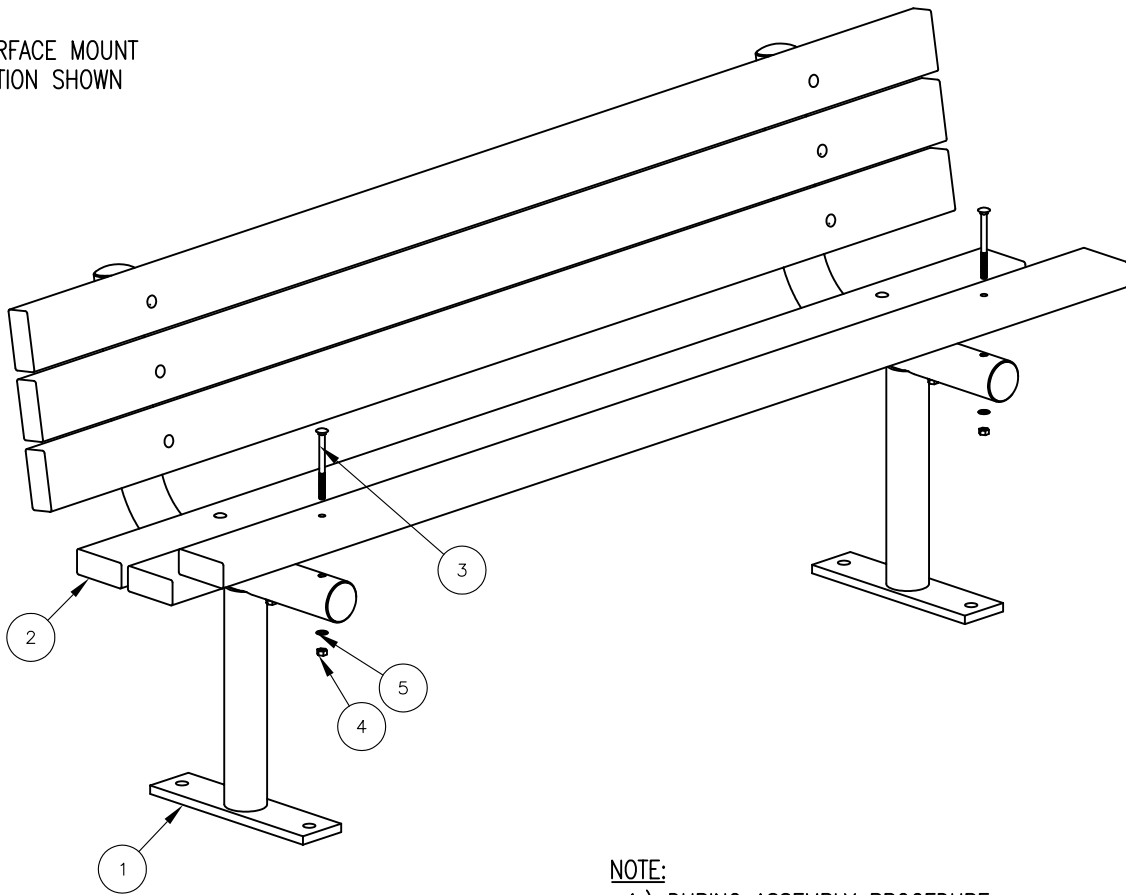

STEP 1:

USE 2 - PCS. SUPPORT FOR SURFACE MOUNT (1)
 6 - PCS. 2" X 4" X 71" WOOD SLAT (2)
 12 - PCS. 5/16" X 4" SS. CGE. BOLT (3)
 12 - PCS. 5/16" SS. HEX NUT (4)
 12 - PCS. 3/8" I.D. X 5/8" O.D. RUBBER WASHER (5)
 ATTACH SLATS (2) TO SUPPORT FOR SURFACE MOUNT (1)
 USING HARDWARE (3, 4 & 5). TIGHTEN TO SNUG FIT.
 REPEAT UNTIL ALL SLATS ARE ATTACHED.

STEP 2:

UPON COMPLETION OF BENCH ASSEMBLY SQUARE
 COMPONENTS THEN TIGHTEN ALL HARDWARE.

STEP 3:

ANCHOR ACCORDING TO SUPPORT OPTION USED.
